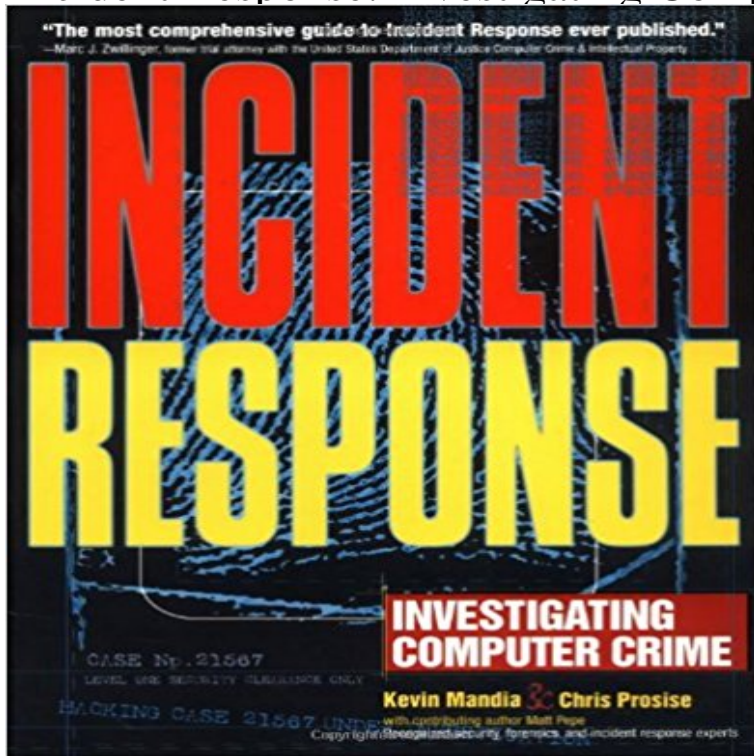


Incident Response: Investigating Computer Crime
