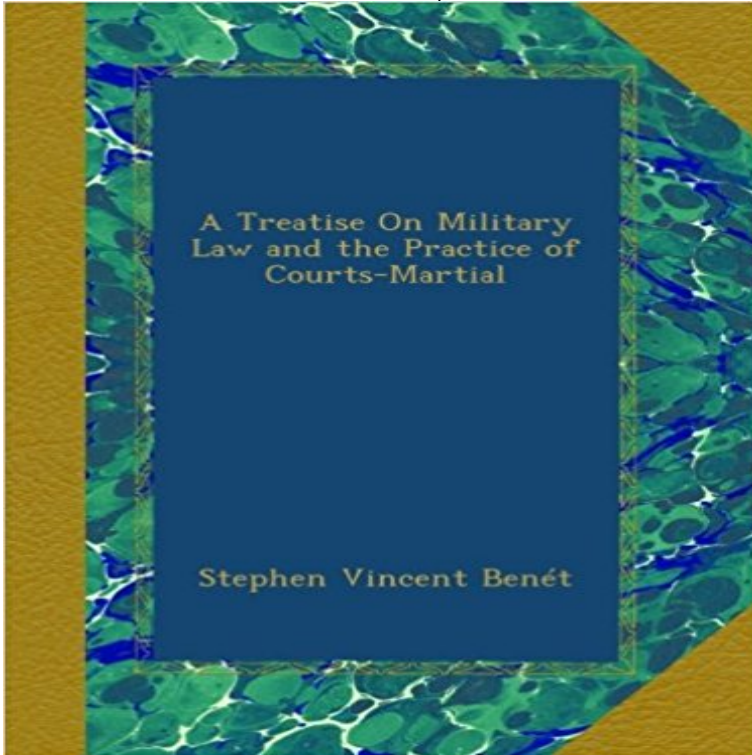


# A Treatise On Military Law and the Practice of Courts-Martial
