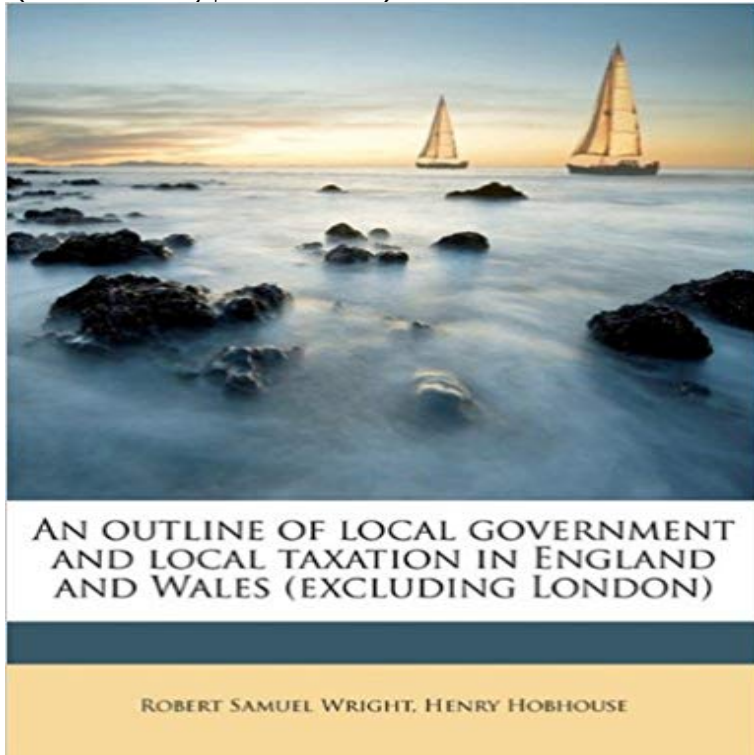


# An outline of local government and local taxation in England and Wales (excluding London)
