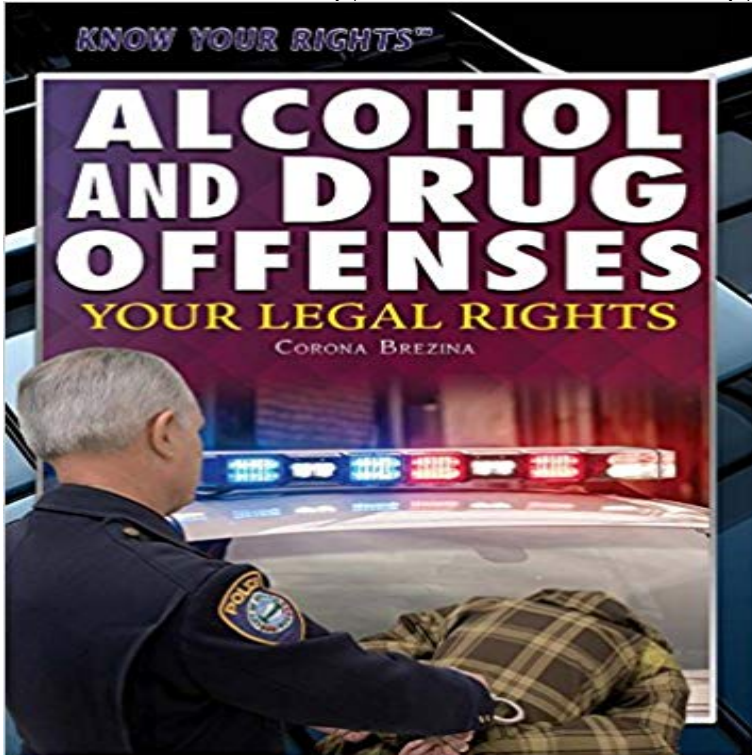


Alcohol and Drug Offenses: Your Legal Rights (Know Your Rights)
