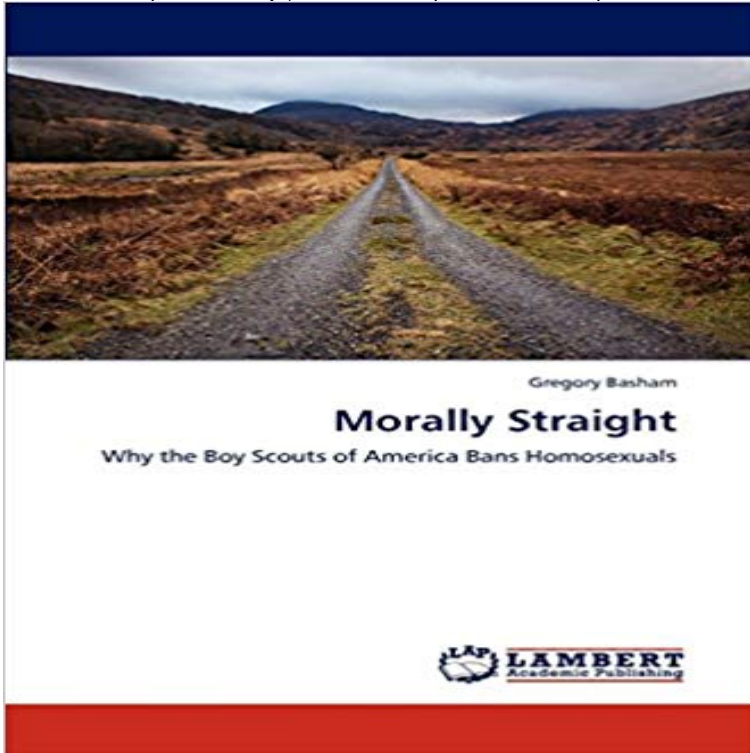


Morally Straight: Why the Boy Scouts of America Bans Homosexuals
