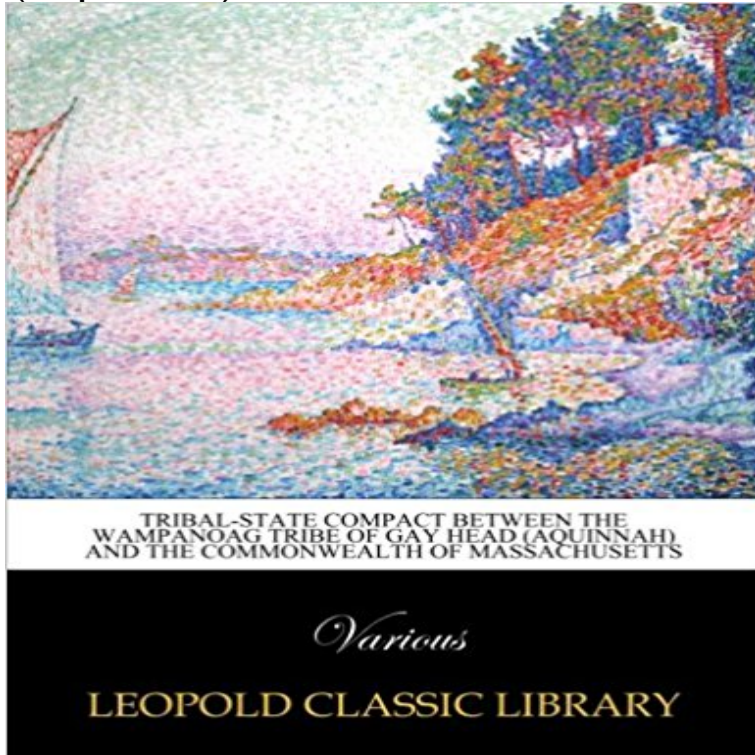


Tribal-state compact between the Wampanoag tribe of Gay Head (Aquinnah) and the Commonwealth of Massachusetts
