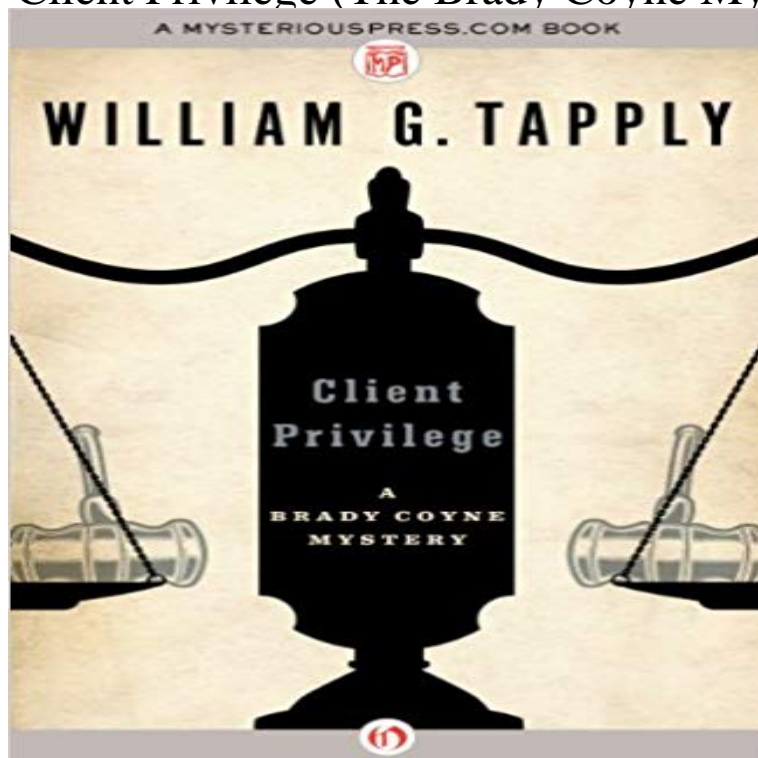


## Client Privilege (The Brady Coyne Mysteries Book 9)
