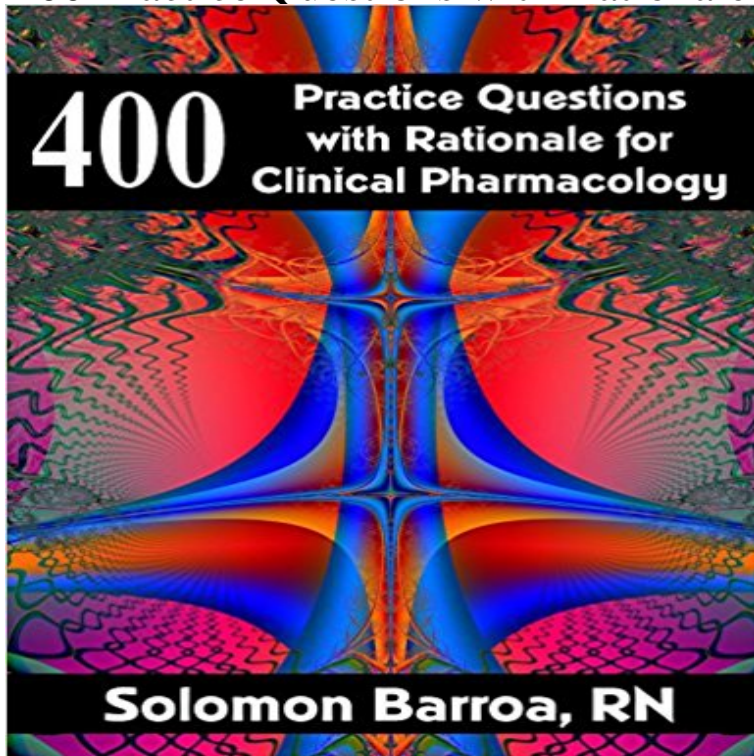


## 400 Practice Questions with Rationale for Clinical Pharmacology
