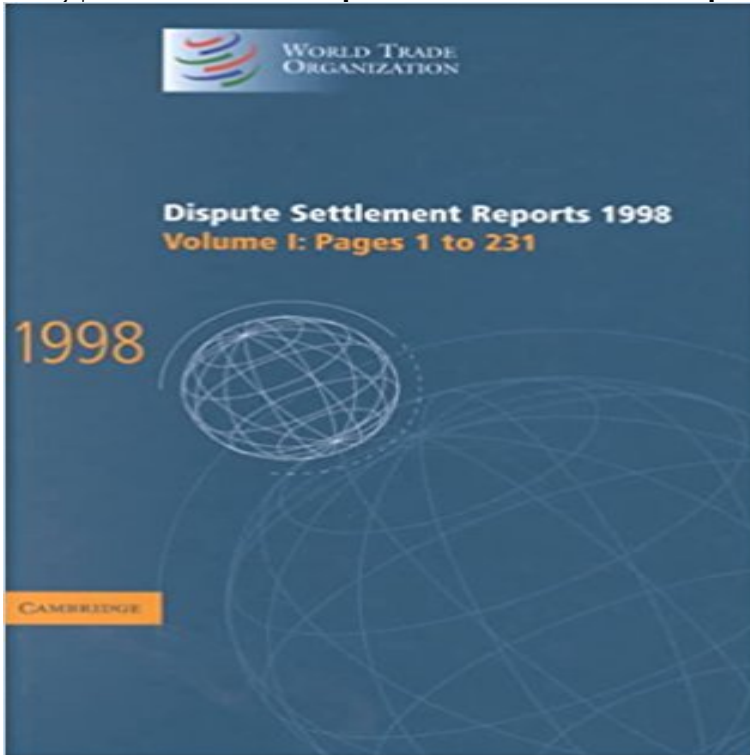


## Dispute Settlement Reports 1998: Volume 1, Pages 1-231 (World Trade Organization Dispute Settlement Reports)
