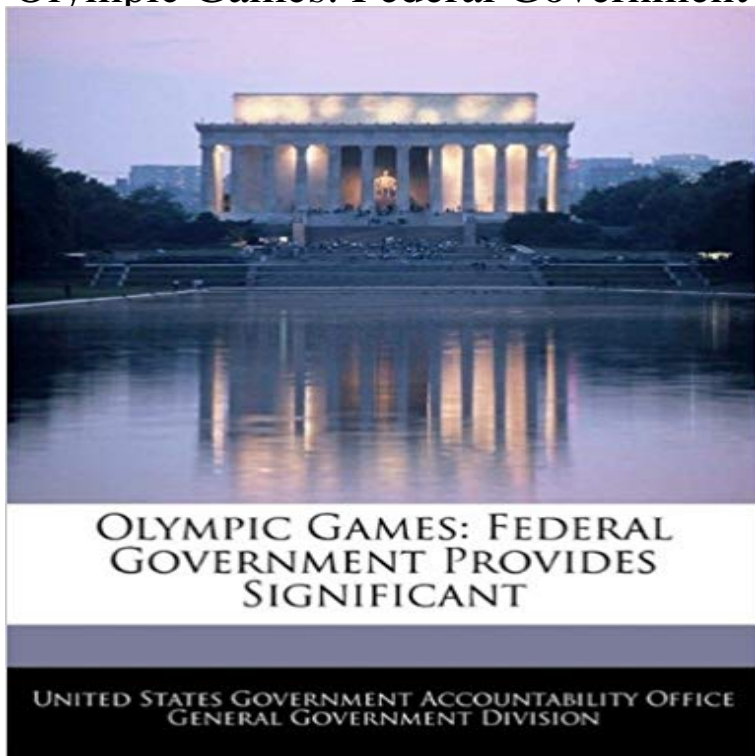


## Olympic Games: Federal Government Provides Significant
