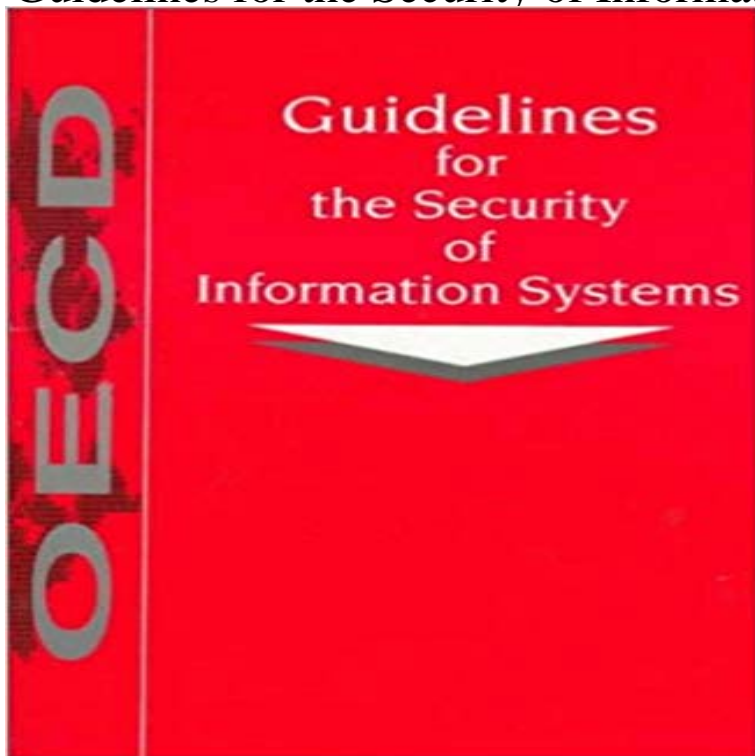


Guidelines for the Security of Information Systems
