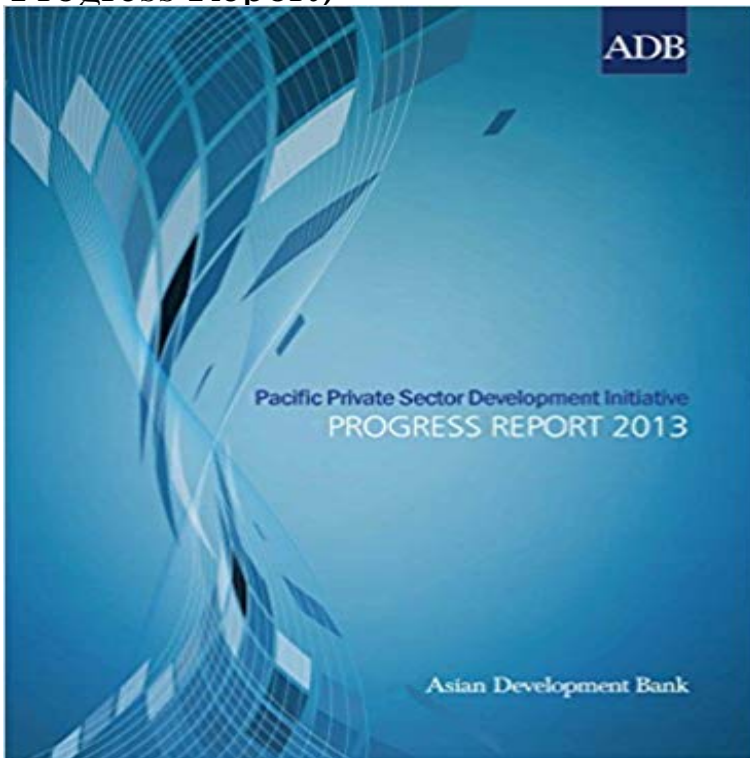


Pacific Private Sector Development Initiative: Progress Report 2012-2013 (Pacific Private Sector Development Initiative Annual Progress Report)

This publication describes PSDI's progress on recent and ongoing initiatives and reviews the analytical basis for reform in the region.
