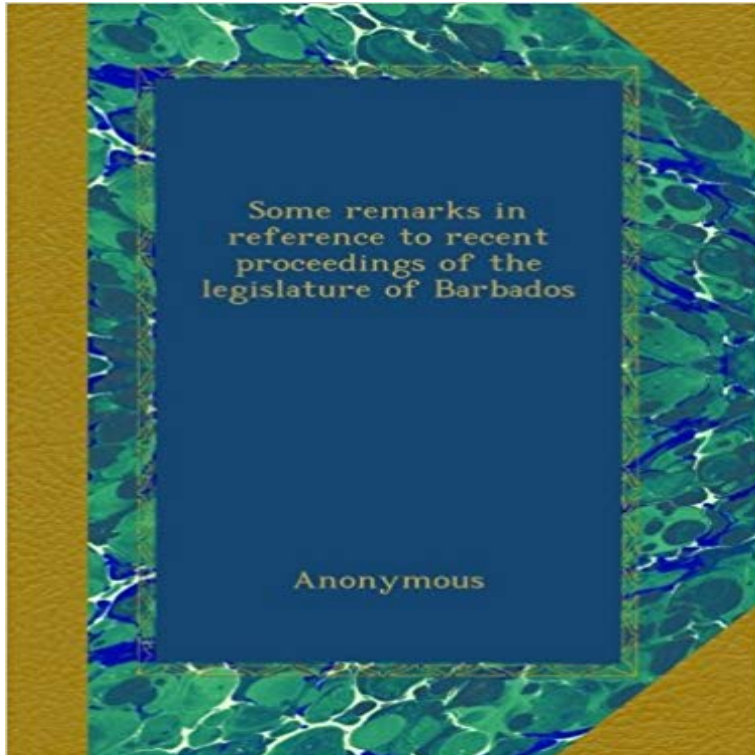


## Some remarks in reference to recent proceedings of the legislature of Barbados
