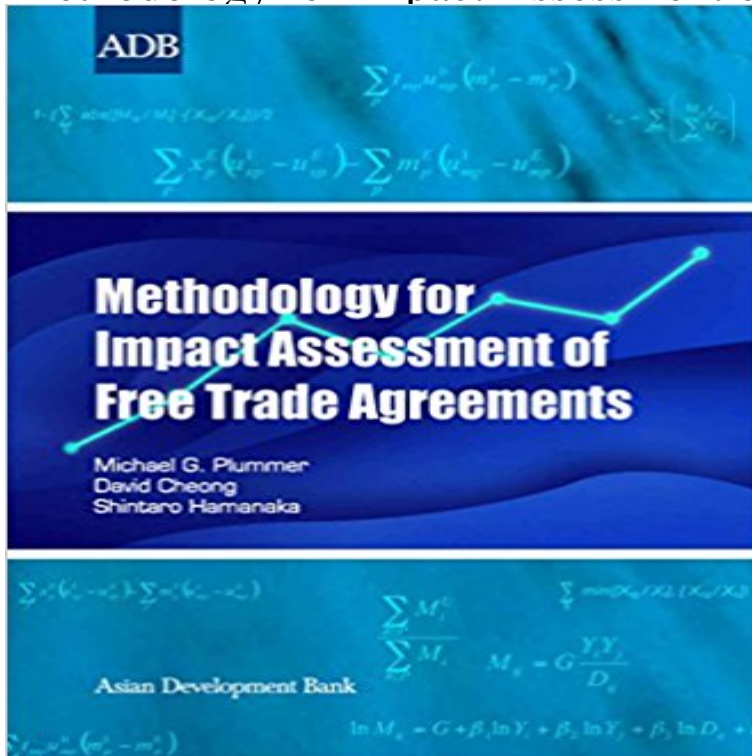


Methodology for Impact Assessment of Free Trade Agreements
