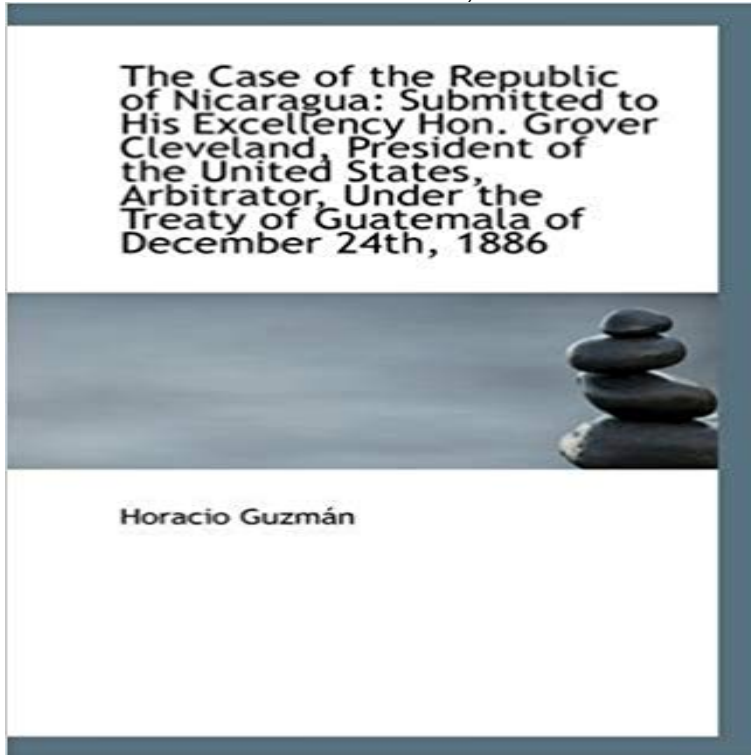


The Case of the Republic of Nicaragua: Submitted to His Excellency Hon. Grover Cleveland, President
