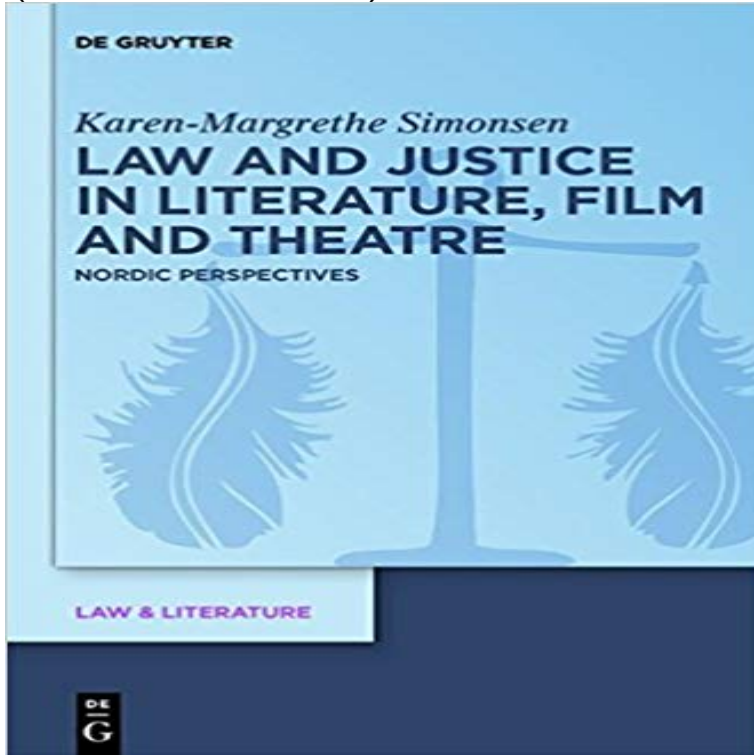


Law and Justice in Literature, Film and Theater: Nordic Perspectives (Law & Literature)
