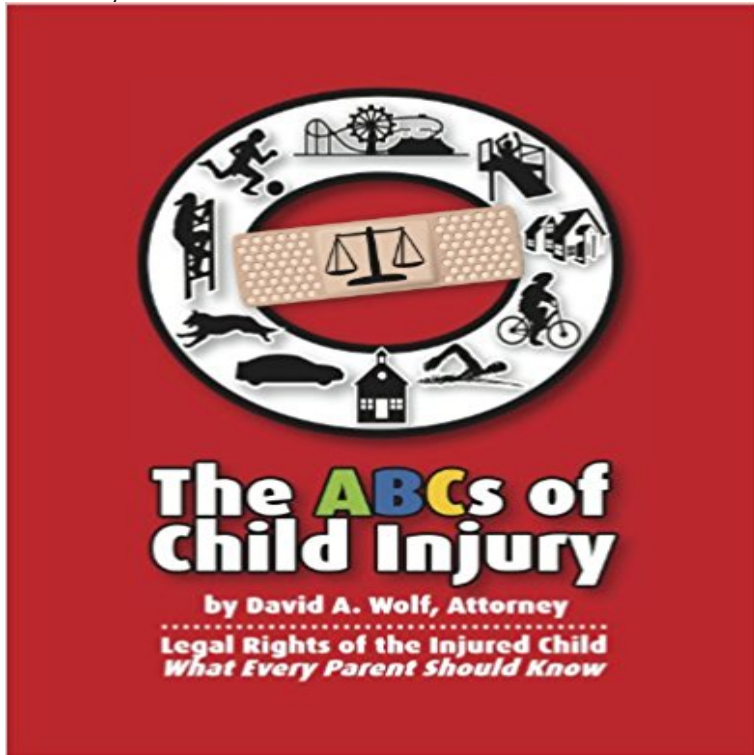


The ABCs of Child Injury - Legal Rights of the Injured Child - What Every Parent Should Know
